Board Committee on Member Oversight authorized release of proposed "Ca. Attorney Guidelines of Civility and Professionalism".

The proposal is available at the State Bar's web site, calbar.ca.gov. On the home page click on the "Public Comment"

There are two versions of the proposed Guidelines. A 14-page version contains the entire set of guidelines, which consists of an Introduction, 21 Sections with examples, and a voluntary attorney pledge at the end. The second version condenses the guidelines into 2-pages without the Introduction and the examples.

Before the proposed Guidelines were submitted to the Board Committee on Member Oversight, the Attorney Civility Task Force made an earlier version of draft standards of civility available for informal feedback in February and March. The feedback received on the earlier version allowed the task force to have the benefit of a wide range of input for the proposed Guidelines.

Law Library Report - - Mike Colantuono

Major items discussed at the Law Library Trustees meeting of May 9th were the new WiFi service available to Courthouse patrons, finances, insurance, and new borrowing policies for Nolo Press books.

With funding from the Administrative Office of the Courts, the Court has established WiFi wireless internet access for the benefit of attorneys and others with laptops and other wireless devices. Service is strongest in and near the Library and 15 minutes of use are available without a password. If you need to work for longer than 15 minutes, check in with Library staff, who can give you the pass word. The pass word will change periodically to prevent "cyber squatters" from monopolizing this service.

May fiscal reports show the Library with positive cash flow for the current fiscal year through the end of April, with our reserves climbing from the dip caused by the many annual subscriptions due in March. As of April 30th, the Library had reserves of \$21,075. While our finances still require close monitoring, it appears that no further subscription reductions will be needed in the near term.

We continue to examine insurance options. After reducing our insurance bill by several thousand dollars last year by joining the County's risk pool, we are now looking at the valuation of our books (our primary asset) to make sure they are appropriately insured. There may be some room to further reduce our premiums without leaving the Library underinsured.

Finally, the Board approved a new policy for circulation outside the library of Nolo Press books – the most popular resource for lay users of the Library and the books most commonly unreturned. A new checkout agreement was approved and a \$1 per day fine established. Those who fail to return books will be barred from further borrowing.

Topics for discussion at our June meeting include finances, insurance and the possibility of a reduced meeting schedule, as stable Library staffing has now put us in a position where bi-monthly meetings may be sufficient.

ADR NOTES:

SURVEY SHOWS LAWYERS PREFER MEDIATION

The ADR Section survey of ADR preferences, with results now tallied, makes clear that Nevada County lawyers favor mediation over other ADR processes. Though the sample (31 out of more than 120) was disappointingly small, and though the ADR Section members claim no polling or statistical expertise, it seems clear from the responses that our Bar has found mediation to be a useful alternative to litigation.

In response to the question that asks for a scoring of preference for the four processes of direct negotiation, mediation, settlement conferencing and non-binding arbitration, thirty of the thirty one respondents put direct negotiation either first or second and twenty five put mediation first or second, with only eight scoring settlement conferencing at the higher values. Non-binding arbitration came in a distant last. Since cost as well as effectiveness was being considered here, it is not surprising that a majority preferred low cost direct negotiation. But, where direct negotiation is either not preferred or has not worked, it is clear that local attorneys opt for mediation over the other alternatives.

This conclusion is bolstered by the results of the second question asking for the frequency of settlements reached in the four processes. The largest number indicated "often" or "most often" for direct negotiation, and a close second ranked mediation in those frequencies. Again, non-binding arbitration came in a distant last. These results were further confirmed by the respondents' comments, which tended to heavily support mediation, as a process the Court should encourage, several suggesting it should be encouraged earlier in the litigation process. Twenty-one respondents said their clients also have shown interest in mediation.

The survey sought further to identify what traits lawyers look for in a neutral, including retired judges, when an ADR process is to be used. We asked you all to rank your preferences with respect to the following traits: process training, legal scholarship, judicial experience, community prominence, subject matter experience, communication skill, sociable demeanor and fee rate. The clear winner here was communication skill, with process training second. Subject matter experience was thought important by eleven respondents, and judicial experience was put
